\$32,949 to Children's Hospital at Westmead in Sydney, Australia. The first animal model for RTD (roundworms) were developed as part of this research.

\$50,000 to the University of Bari Aldo Moro in Italy. This funded Phase 1 of the study of RTD patient fibroblasts and neurons (brain) and helped us understand mechanisms of transport of riboflavin in neurons.

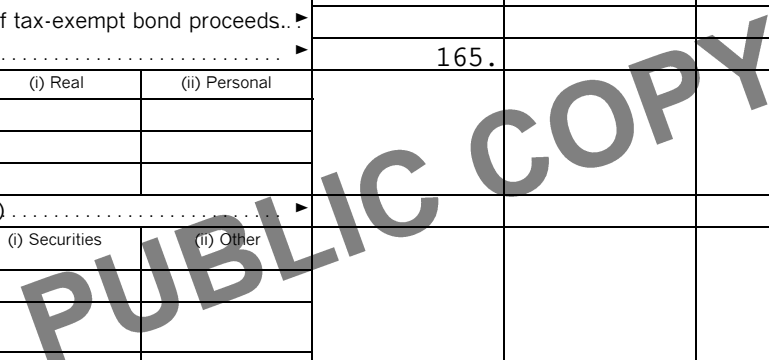

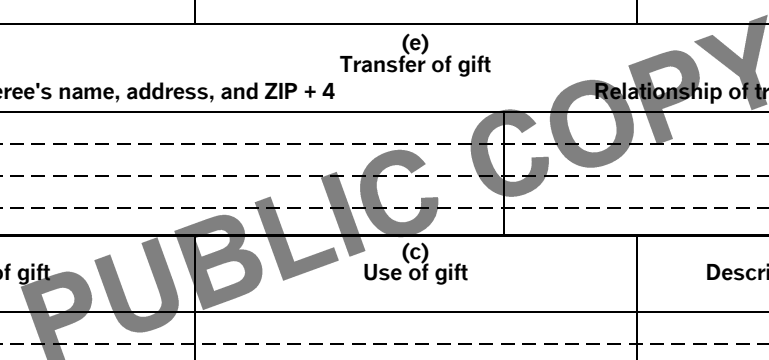
